OF THE TOWN OF FAIRVIEW

A BYLAW FOR THE TOWN OF FAIRVIEW IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF AMENDING BYLAW 1046/GEN/2018

Whereas, Pursuant to Bylaw 1046/GEN/2018 adopted on the 2nd day of October 2018 for the purpose of standardizing enforcement of bylaws and penalties for offences, and

Whereas, Provisions of the Municipal Government Act, Revised Statutes of Alberta 2000 Chapter M-26, Section 191 provides that a Council is authorized to amend a bylaw in the same way the original bylaw was passed; and
