

# BYLAW NO. 1098/UTIL/2024

# A BYLAW FOR THE TOWN OF FAIRVIEW IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF AMENDING UTILITY RATES

**WHEREAS**, Pursuant to Bylaw 1048/UTIL/2018 passed on the 6th day of November 2018, regulating the water, sewer, sanitation, and recycling systems of the Town of Fairview; and

**WHEREAS**, Pursuant to the Municipal Government Act, Section 191, Council is authorized to amend a bylaw in the same way the original bylaw was passed;

NOW, THEREFORE, Council of the Town of Fairview, duly assembled, enacts as follows:

- 1. Replace Schedule A from Bylaw 1048/UTIL/2018 with the attached
- 2. Replace Schedule B from Bylaw 1048/UTIL/2018 with the attached
- 3. Replace Schedule C from Bylaw 1048/UTIL/2018 with the attached
- 4. Bylaw 1098/UTIL/2024 shall take force and effect on January 1, 2025. For legal agreements that require notification periods, rates as specified in Bylaw 1090/UTIL/2023 shall be in effect until such time that the required notification period has been satisfied.
- 5. Once required notification periods have been satisfied as per Section 4, Bylaw 1090/UTIL/2023 shall be repealed.
