Tax Penalties

On January 1, 2025, all unpaid taxes are deemed in arrears. A 15% penalty will be imposed on all property tax arrears in accordance with Bylaw 696/TAX/87. Payments may be made at your local bank, telephone, online banking, mail, or at the Town Office by cash, cheque or debit. Alternatively, payment by cheque (do not drop cash) may be dropped into the dropbox at the west entrance of the Provincial Building. Tax Installment Plan

Persons owning property in the Town of Fairview wishing to pay their current 2025 property taxes by monthly installments under the Town's Pre-authorized Tax Installment Payment Plan may do so by making arrangements at the Town Office by January 10, 2025. SNOW REMOVAL REMINDER

As snow removal season is here, we would like to remind residents that the Traffic Bylaw (965/TR/2010) states that vehicles parked on the curb must be moved within 72 hours, especially when that roadway is being plowed. We also kindly ask residents to not shovel, push or blow snow back onto the street when they are clearing their driveways as per Traffic Bylaw (965/TR/2010-Section 19). It makes ridges and ruts that hamper safe driving for private and commercial vehicles.

Please remove your black and blue bins from the street, as soon as they are emptied on Wednesdays, to clear the curbs for the snowplows. Let's all work together to keep our roadways safe this winter!

BYLAW REMINDERS: 1077/AC/2022 Animal & Responsible Pet **Ownership Bylaw**

Reminding town residents to update pet licences

• All dog and cat owners are required to licence animals over 3 months old • Residents of Country View Estates and North View Estates who are permitted horses and chickens are required to obtain unit licences • No more than four animals with a maximum of 3 dogs are allowed

- Fine for keeping the maximum number of animals allowed is \$200 No livestock is allowed within Town limits
- Fine for failing to obtain a dog licence is \$100, failure to wear licence is \$75
- Fine for failing to obtain a cat licence is \$30, failure to wear licence is \$20 Dog or cat licences are \$20 for non-spayed or non-neutered
- Dog or cat licences are \$10 for spayed or neutered
