PROPERTY ASSESSMENT NOTICES

The assessment notices will be mailed on February 10, 2026. Tax notices will be mailed out in May. If you did not receive your assessment notice, please call the Town Office, and request a notice. All non-linear assessment complaints for the Town of Fairview along with the applicable fees are due by April 20th, 2026. An assessment complaint must be filled out using the Government of Alberta Assessment Review Board Complaint Form (LGS1402). This form can be provided to you by the Town of Fairview office or you can download it from the Municipal Affairs website at:

Are you a Business Owner in Fairview?

Here's what you need to know!

Do I need to pay a yearly fee?

If your business falls under one of the following categories, you are exempt from fees:

- Businesses located in commercial zones
- Charities, religious organizations, sports and youth groups
- Non-profit community services
- Wholesale suppliers and produce personally grown, raised, or fished
- Farmer's Markets (Town approved)
- Events or festivals (Town approved)
 - Garage sales

How much is the license fee for a Home-Based Business?
