PROPERTY ASSESSMENT NOTICES

Your assessment Notice was mailed out in February. Property Tax Notices will be mailed out in May. If you did not receive your assessment notice, please call the Town of Fairview Administration Office and request it. All non-linear assessment complaints of the Town of Fairview, along with the applicable fees are due by April 11, 2023. An assessment complaint must be filled out using the Government of Alberta Assessment Review Board Complaint Form (LGS1402). This form can be provided to you by the Town of Fairview Administration Office or you can download it from the Municipal Affairs website at:

NOTICE OF INTENT TO CONSIDER ADVERTISING STATUTORY NOTICES BYLAW 1085/GEN/2023

Take Notice that the Town of Fairview Council has on March 7, 2023 given the first reading to Bylaw 1085/GEN/2023 which, upon final approval, the Bylaw would provide alternative methods of advertising proposed Bylaws, resolutions, meetings, Public Hearings, and other decisions/actions that are legally required to be advertised.

Council may, in accordance of the Municipal Government Act sections 230(1) and 606.1(3) hold the Public Hearing for Bylaw 1085/GEN/2023 Advertising Statutory Notices Bylaw at the April 4, 2023 regular Council Meeting. Unless a petition of the electors for a vote on the proposed Bylaw is presented in accordance with section 231(4), Council intends to present the proposed Bylaw for approval.
