NOTICE OF INTENT TO CONSIDER AMENDING THE TOWN OF FAIRVIEW LAND USE BYLAW WITH BYLAW 1101/LUO/2025

TAKE NOTICE THAT THE TOWN OF FAIRVIEW COUNCIL HAS ON **APRIL 1, 2025** GIVEN THE FIRST READING OF **1101/LUO/2025** WHICH, UPON FINAL APPROVAL, THE BYLAW WOULD PROVIDE **AMENDING THE TOWN OF FAIRVIEW LAND USE BYLAW.**

COUNCIL MAY, IN ACCORDANCE WITH THE **MUNICIPAL GOVERNMENT ACT (MGA) PART 7 AND SECTION 606**, HOLD THE PUBLIC HEARING FOR **1101/LUO/2025 AMENDING THE TOWN OF FAIRVIEW LAND USE BYLAW** AT THE **MAY 6, 2025** REGULAR COUNCIL MEETING.

UNLESS A PETITION OF THE ELECTORS FOR A VOTE ON THE PROPOSED BYLAW IS PRESENTED IN ACCORDANCE WITH MGA SECTION 231, THE COUNCIL INTENDS TO PRESENT THE PROPOSED BYLAW FOR APPROVAL.
