## School and Playground Zones

Playground Times are in effect every day from 8:30 am to 1 hour after sunset



School Zone Times  
(school days only) are:  
8:00 am to 9:30 am  
11:30 am to 1:30 pm  
3:00 pm to 4:30 pm



- The speed limit for school and playground zones is 30km/hr
- A school zone ends where a traffic sign indicates a higher speed or the end of the school zone
- Do not pass another vehicle travelling in the same direction within a school zone, when the school zone is in effect
- Children and young adults may be walking or crossing the road and you must use caution when driving through a school or playground area

## ONLINE PAYMENTS

Do you pay your taxes and/or utilities online? Did you pay before the due date and your payments are not reflected on your current bill? Time to check if your account number information is up to date in your banking portal.

Please verify that the account number you are paying through online banking matches your invoice you are paying, you may be building a huge credit on an inactive account.

The Fairview town office is only required to apply the payments to the accounts you have entered in your online banking app. If we notice that the account entered is inactive we will contact you to change that information but the responsibility to have the correct account information entered is yours, please check and update your account if necessary.

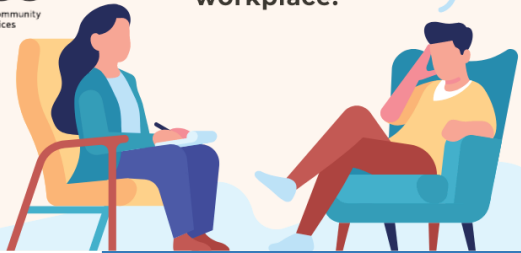

# Notice of application to be filed for approval to renew the natural gas franchise agreement between the Town of Fairview and ATCO Gas and Pipelines Ltd.

## Application summary

The Alberta Utilities Commission expects to receive an application from ATCO Gas and Pipelines Ltd. to renew its franchise agreement with the Town of Fairview, following the submission deadline indicated below.

The franchise agreement will, subject to further renewal, continue to allow ATCO Gas and Pipelines Ltd. the exclusive right to deliver natural gas to the residents of Fairview for approximately ten years from the effective date of the franchise agreement.

The franchise fee rate rider percentage will remain the same at 19.31% effective December 1, 2024. Including linear taxes, the average monthly franchise fee for an average residential customer is forecast to remain at \$11.94. The franchise fee is calculated based on distribution charges. An average residential customer uses about 115 gigajoules per year.
