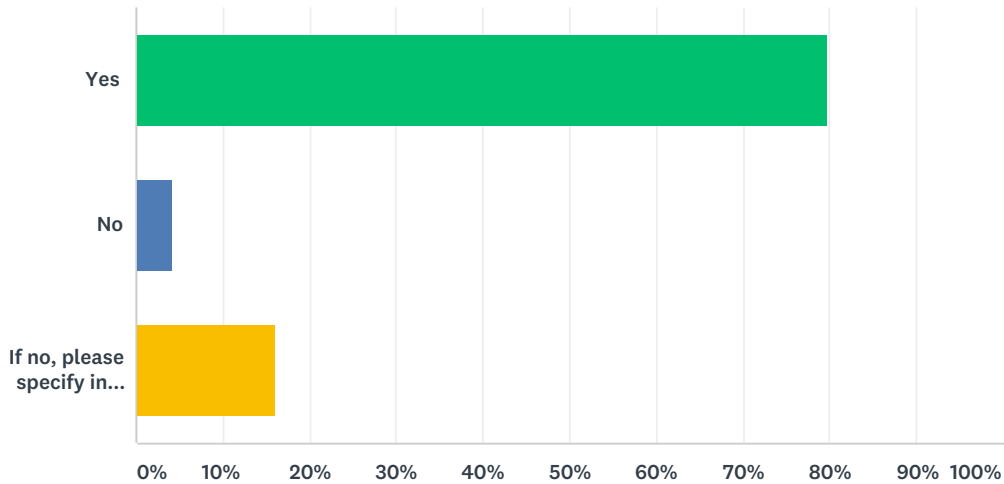


Q1 Are you a resident of the Town of Fairview?

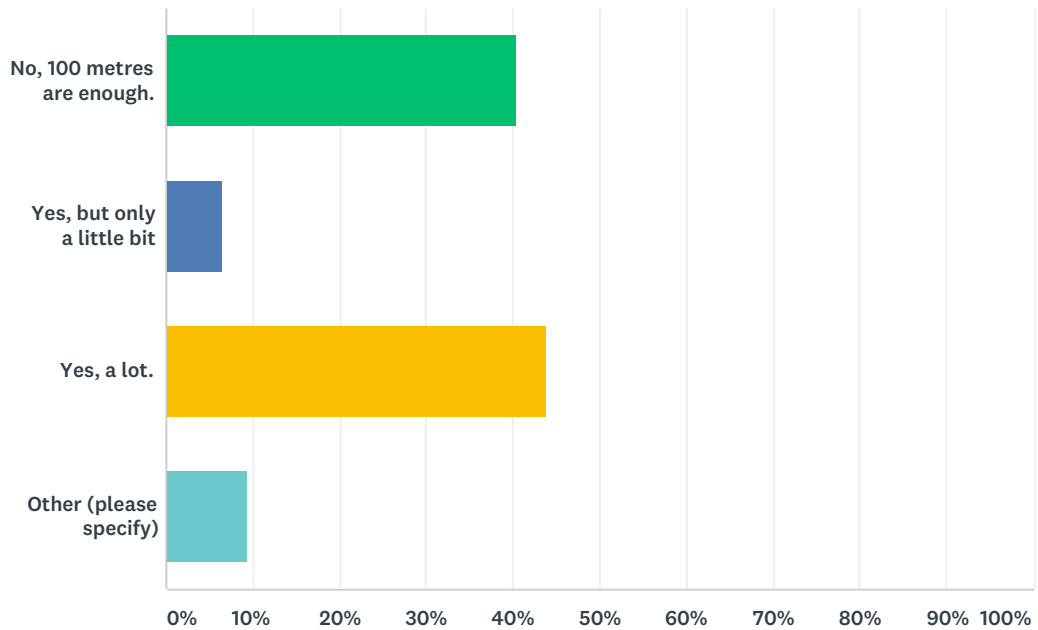

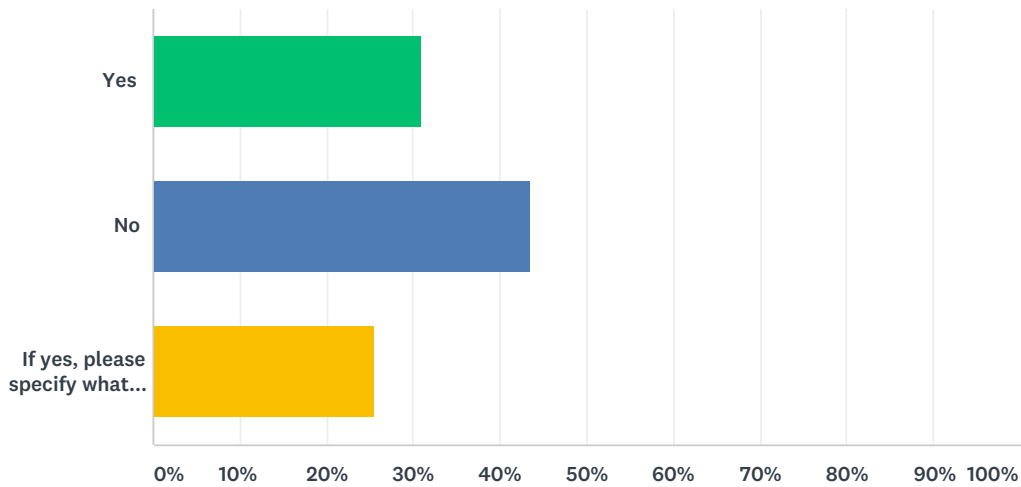

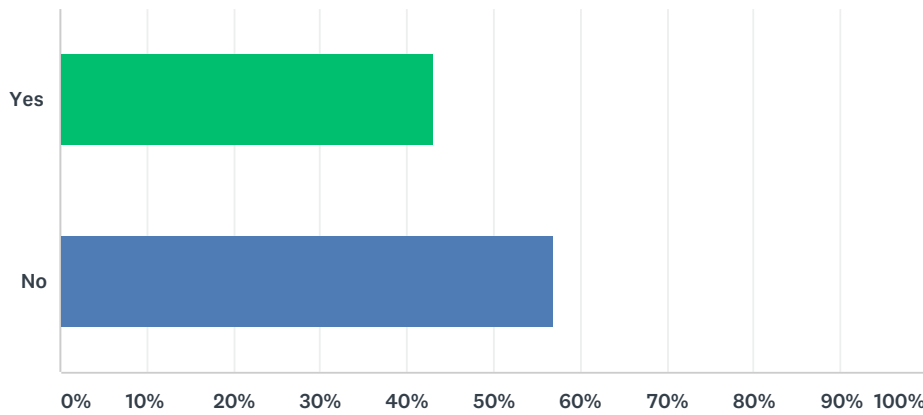

Q4 Do you think there should be a separation distance requirement between liquor stores and cannabis retail stores?

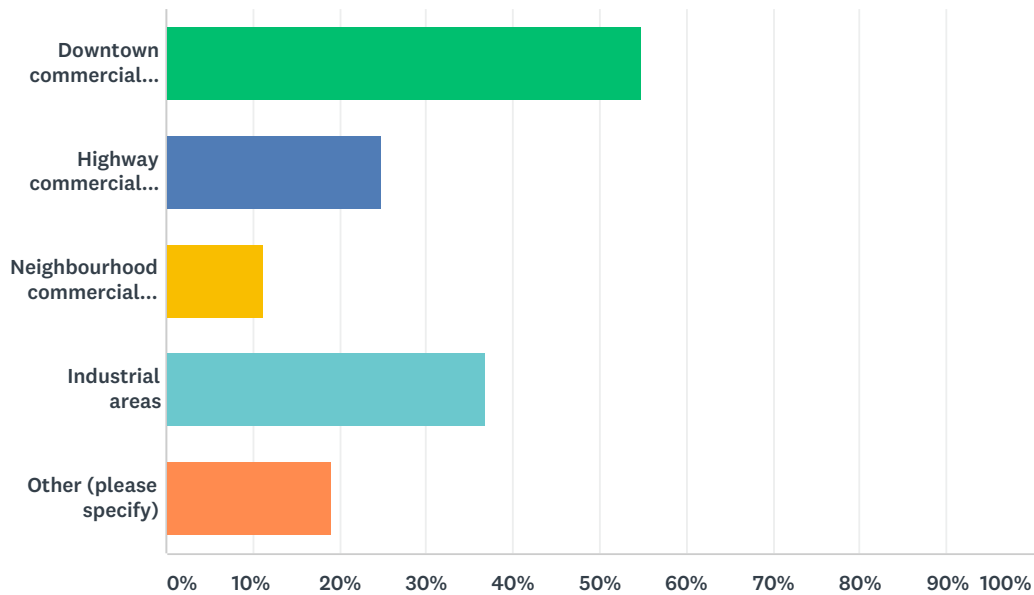

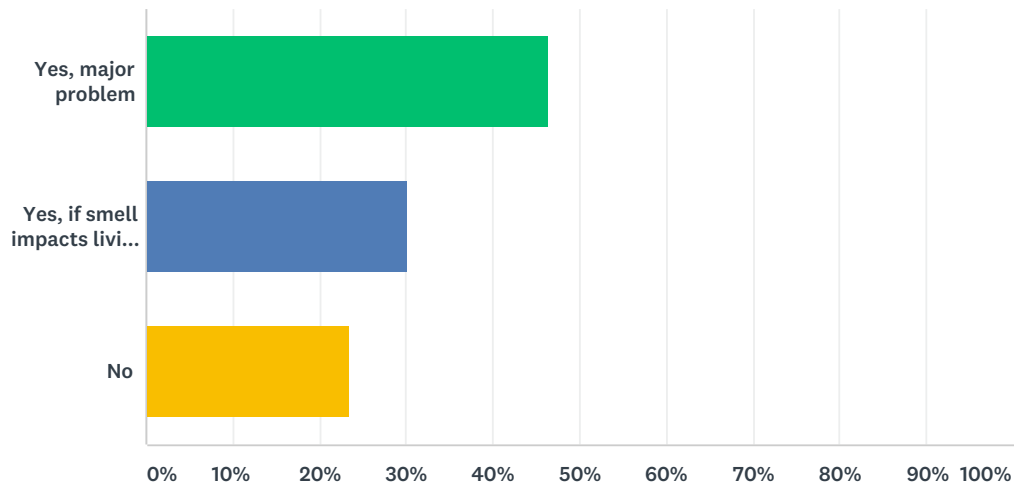

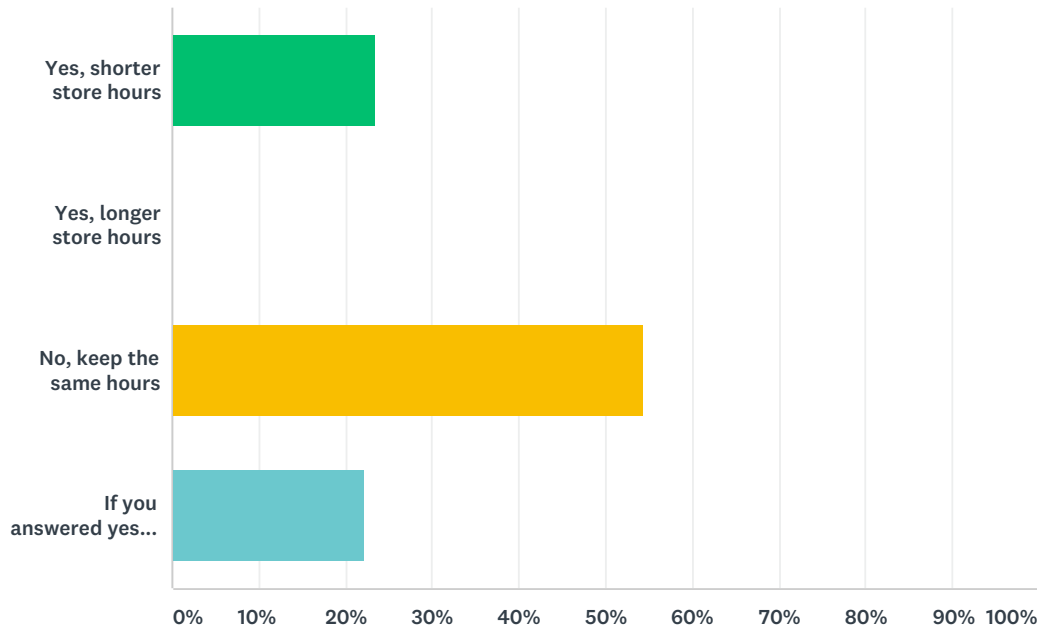
